

SUMMARY ANNUAL REPORT

For Omaha Track Health And Welfare Benefit Plan

This is a summary of the annual report of the Omaha Track Health And Welfare Benefit Plan, EIN 47-0692129, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Omaha Track, Inc. has committed itself to pay certain self-insured Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Blue Cross Blue Shield Nebraska, Ameritas Life Insurance Corp., Principal Life Insurance Company, and Healthjoy - Curalink to pay Medical, Vision, Life Insurance, Short-term Disability, Long-term Disability, Employee Assistance Program, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$2,450,896.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2023, the premiums paid under such "experience-rated" contracts were \$2,229,100 and the total of all benefit claims paid under these contracts during the plan year was \$1,158,146.
